#### ADVICE TO SOUTH WALES FIRE AND RESCUE SERVICE OFFICERS

South Wales Fire and Rescue Service requires you to declare Personal Interests on the Register of Officers' Interests form **within 28 days** of your Interest becoming apparent. Such Interests have to be updated by you **within 28 days** of any change.

#### Interests of Close Family Members

In line with Audit Wales' requirements, your declaration must include the Interests of close family members, ie partners and/or children.

In essence a "Related Party Transaction" is a transaction which an Officer or their close personal associate via another entity (company, trust etc) has with the Service, ie provision of services or contractual arrangements.
